Community Boards

There are 59 community boards in New York City: 12 are located in Manhattan, 12 in the Bronx, 14 in Queens, 18 in Brooklyn, and three on Staten Island. Each community board is responsible for cooperating with, advising, and assisting any public agency or office concerning matters that relate to the welfare of the district and its residents. Each board submits recommendations to the Mayor, Borough President, City Council, and other City officials, which are in the best interest of the district. Every board conducts public hearings and submits recommendations on the capital and expense budgets. Community boards play an advisory role in zoning and other land use issues, in community planning and in the coordination of municipal services. Each board is required to hire a full-time district manager and other staff to run a district office, which is responsible for resolving residents' service delivery problems.

Summary and Highlights

The Fiscal 2012 Preliminary Budget for the Community Boards (approximately \$14.6 million) is \$138,000 less than the agency's Fiscal 2011 Adopted Budget of \$14.7 million. At the time the Fiscal 2011 Budget was adopted, the City's Financial Plan for the Community Boards in Fiscal 2012 was already approximately \$138,000 below the Fiscal 2011 appropriation. This resulted from prior Plan reductions. Neither the November 2010 Plan nor the February 2011 Plan contained any significant actions pertaining to the Community Boards.

Issues and Budget Highlights

• **Fiscal 2011 Budget - Leases.** The February Plan's City funds budget for the Community Boards in Fiscal 2011 is \$11,700 greater than the corresponding figure at budget adoption in June. This increase is due solely to lease adjustments as follows:

• **Fiscal 2011 Budget – Non-City Funding.** The Adopted Fiscal 2011 Budget for the Community Boards consisted entirely of City funds. The February Plan now contains \$313,000 in categorical grants and \$10,000 in State grants.
