Term and Condition(s) (T&C) – School Lunch:

Fiscal 2015 Term and Condition relating to the school lunch programs, which includes Free Lunch Initiative in standalone Middle Schools (MS) at the Department of Education (DOE or the Department). As a condition to the expenditure of funds appropriated to the school lunch program, the Department shall provide a report to the City Council that list the total amount of collected and uncollected lunch fees; and the number of school lunches served daily, disaggregated by free lunch, reduced-priced lunch, and full-priced lunch.

Rationale:

The DOE's budget documents do not provide detailed information of school lunch programs. With the support of the Council, the Administration launched Free Lunch Initiative in standalone MS in Fiscal 2015. The statistics of the school lunch programs and MS Free Lunch Initiative are vital to the better understanding of the efficacy and sufficiency of the program. This T&C allows the Council to track the number of students served and the number of submitted lunch forms.

Overview:

The City Charter authorizes the Council to attach terms and conditions to any unit of appropriation in either the expense budget or the capital budget that impose certain requirements as a condition of spending. As part of the budget negotiation process, the City Council can propose terms and conditions to be included in the adopted budget. These requirements often consist of reporting on indicators related to the progress of spending the appropriated funds, or certain programmatic aspects of the spending.

Frequency of Reporting:

The update about the status of the school lunch programs should be submitted to the Council by April 1, 2015. The report was submitted to the Council after its deadline, on April 23, 2015.

T&C Data:

The following provided data is as of December 31, 2014 and shows only the schools for which Division of School Facilities provides lunch service. These reports provide a breakdown of participating schools and students, collected forms, fees, and lunches served daily. All the data also provides information by the schools participating in the Universal School Meals program under federal Provision II; the number of lunches served in schools participating in the Community Eligibility Provision (CEP)
