## **Executive Budget Highlights**

- **Total Expense Budget**. The Office of Chief Medical Examiner's (OCME) budget for Fiscal 2015 totals \$63.6 million.
  - The Fiscal 2015 Executive Budget shows an increase of \$6.8 million as compared to the Fiscal 2014 Adopted Budget.
- **Funding Sources.** Nearly all funding, \$59.7 million or 94 percent of OCME's Fiscal 2015 budget is City tax-levy (CTL) funding, with remainder \$3.9 billion, or six percent, from federal funding.
- **Headcount.** OCME's headcount for Fiscal 2015 is 626, an increase of seven positions from the Fiscal 2014 Adopted Budget.
- **New Needs.** The Fiscal 2015 Executive Budget includes \$3.1 million in new needs as outlined below:
  - o <u>OCME Criminalists</u>: \$2.4 million to fund the salaries of 16 criminalists to reduce turnaround time in the DNA lab;
  - o <u>OCME Fire Safety:</u> \$221,000 to fund fire safety director and fire watch services while the alarm is being updated; and
  - o <u>OCME Personal Services</u>: \$552,000 to fund the salaries of one risk/quality assurance manager and eight criminalists on payroll that are not currently funded because of grant reductions.
- Other Adjustments. The Executive Budget for Fiscal 2015 includes \$1.4 million in other adjustments, as outlined below:
  - o <u>Hurricane Sandy.</u> The Executive Budget includes \$1.6 million in FEMA funds to replace equipment and supplies lost during Hurricane Sandy.
  - o <u>Heat, Light & Power.</u> OCME's Fiscal 2015 Executive Budget includes a reduction of \$235,000 for the heat, light and power budget, due to readjustment by OMB.

### Office of Chief Medical Examiner Overview

This report provides an overview of the Fiscal 2015 Budget for the Office of the Chief Medical Examiner (OCME) and a review of the significant actions included in the Executive Budget. OCME's budget for Fiscal 2015 is \$63.6 million, most of which supports personal services (PS) spending. The changes to OCME's Fiscal 2014 and Fiscal 2015 budgets proposed in the November and Preliminary Financial Plans are listed in Appendix 2. ## **New in the Executive Budget**

OCME's budget for Fiscal 2015 increased by \$6.8 million to \$63.6 million as compared to the Fiscal 2014 Adopted Budget of \$56.8 million. This increase is split almost equally between personal and other than personal services, and is attributed to increases in City and federal funds. For Fiscal 2015, OCME has proposed new spending totaling \$3.1 million, and \$1.4 million in other adjustments. New actions in the Executive Plan are highlighted below.

#### **New Needs**

- **OCME Criminalists.** The Executive Budget includes \$2.4 million in Fiscal 2015 and in the outyears to fund the salaries of 16 criminalists to reduce the turnaround time in the DNA lab.
- **OCME Fire Safety.** The Executive Budget includes \$552,000 in Fiscal 2015 and in the outyears to fund the salaries of one risk/quality assurance manager and eight Criminalists on payroll that are not currently funded because of grant reductions.
- **OCME Personal Services.** The Executive Budget includes \$221,000 for Fiscal 2015 to fund a fire safety director and fire watch services while the alarm is being updated.

### **Other Adjustments**

- **Hurricane Sandy.** The Executive Budget includes \$1.6 million in FEMA funds to replace equipment and supplies lost during Hurricane Sandy. In total, OCME is requesting \$2.7 million, with OCME doing procurement in two phases due to the volume.
- **Heat, Light & Power.** The Executive Budget includes a reduction of \$235,000 for the Heat, Light and Power budget, due to an adjustment based on the Mayor's Office of Management and Budget's (OMB) projections. The heat, light and power budget for all agencies are adjusted annually.

# **Executive Budget Highlights**

- **WTC Repository Room.** The 9/11 Memorial Museum is slated to open on May 21, 2014. The Family Room and Repository, final resting place for unidentified remains, is housed in the museum but will only be accessible to family members of 9/11 victims.
  - OCME will spend \$368,000 in Fiscal 2015 for supplies, equipment and four criminalists that will interact and be present to answer any questions for family members.
