## Department of Buildings Financial Summary

### Highlights

- The Department of Building's Executive Fiscal 2011 budget is 5.31 percent less than its Fiscal 2010 Adopted Budget. The \$5.49 million decrease consists of \$3.55 million in PS and \$ 1.95 million in OTPS (see page 3).
- The Department is both increasing fees (record management) and implementing new fees (low/high pressure boiler, elevator, façade, and hazardous re-inspections) to generate \$1.84 million in Fiscal 2010 and \$10.7 million in Fiscal 2011 (see page 6).
- The Department is proposing 20 staff reductions in the Borough Support Units and other Central Units that have experienced decreased workloads to achieving savings of \$1.43 million in Fiscal 2011 and \$1.66 million in the outyears (see page 6).

# **Department of Buildings**

The Department of Buildings (DOB) ensures the safe and lawful use of over 950,000 buildings and properties by enforcing the City's Building Code, Electrical Code, Zoning Resolution, New York State Labor Law, and New York State Multiple Dwelling Law. The Department performs plan examinations, issues construction permits, inspects properties, licenses trades, and issues Certificates of Occupancy and Place of Assembly permits. Anyone who intends to demolish, alter, build an addition, or erect a new structure must obtain a building permit from the Department to ensure that the resulting property structure complies with all applicable laws.

#### **Key Public Services Areas**

- Ensure the safe and lawful use of buildings and properties by enforcing the Building Code, Zoning Resolution, and other applicable laws.
- Facilitate compliant construction through the timely delivery of services.

#### **Critical Objectives**

- Protect public safety by inspecting construction and buildings to ensure compliance.
- Prevent construction-related injuries and fatalities.
- Enforce Building Code and zoning regulations.
- Improve the enforceability of violations issued.
- Respond to public complaints in a timely manner.
- Ensure that individuals have proper qualifications to perform regulated work.
- Improve the timeliness of construction plan reviews, permit issuance, and related inspections.

# **Summary and Highlights**

### **PS and OTPS 001-002**

The operating budget of an agency is structured into several levels, each of which provides varying levels of detail on an agency's spending plans. The City Charter requires that U/A's represent the amount appropriated for Personal Services (i.e. salaries) or Other Than Personal Services (i.e. supplies) for a particular program, purpose, activity, or institution. The table below presents the Department's budget from the Fiscal 2008 Actuals up to the Fiscal 2011 Preliminary Budget.

The Department of Building's Executive Fiscal 2011 budget is 5.31 percent less than its Fiscal 2010 Adopted Budget. The \$5.49 million decrease consists of \$3.55 million in PS and \$1.95 million in OTPS.

The PS budget decrease is the result of the reduction of 65 positions through natural attrition to accommodate for a downturn in the construction activity, and the additional proposed 20 headcount reduction in the Executive Fiscal 2011 Budget. DOB is distributing the 65 headcount reductions in Fiscal 2010 and will take out the budget associated with certain vacant positions by the start of Fiscal 2011. The new proposed 20 staff reductions in the Executive Fiscal 2011 Budget would come from Borough Support Units and Central Units. The \$1.95 million decrease in OTPS funding is the result of reduction in contract services.

Since Mayor Bloomberg's first year in office in 2002, the Department's budget has increased by more than \$46.17 million in response to the booming construction industry and to strengthen the Department's operations. The Fiscal 2011 Executive Budget for the Department is \$98 million, which is 89.13 percent more than the \$51.8 million appropriated in the Fiscal 2003 Adopted Budget. During the same period, revenues have increased by \$36.87 million as the result of increase revenues from licenses and permits, fees, and fines. The Department's current projected revenue for Fiscal 2011 is \$127.2 million, which is 40.8 percent more than the \$90.3 million the Department generated in Fiscal 2003 (See table on page 4).

Prior to the recent recession, New York City was in the midst of a construction boom. As a result DOB saw a huge increase in the number of construction inspections. Between Fiscal 2007 and Fiscal 2009, inspections increased by 6 percent. The increase in construction activity has led to an increase in Priority A emergency complaints (9.1%) and construction injuries (101%). Further, the violations and summonses issued by DOB have increased by 37% while those issued by the Environmental Control Board have increased by 52%. DOB has not had to layoff staff and, thus, has been able to respond quickly to construction related issues.

# **Executive Budget Action Analysis**

### Program to Eliminate the Gap (PEG)

As part of the citywide PEG program, the Department was required to come up with cost savings in its Fiscal 2011 expense budget. As a result of the agency's revenue generating ability, DOB was able to meet its PEG target by both increasing fees and implementing new ones. The agency's Fiscal 2011 Executive budget includes \$10.7 million in additional and new revenue for Fiscal 2011 and in the outyears. In addition to the proposed revenues, the Department will achieve savings of \$1.43 million in Fiscal 2011 and \$1.66 million in Fiscal 2012 and in the outyears by laying off 20 staff.

- **Record Management Fees.** The Department will increase records of management fees for scanning and microfilming documents from \$35 to \$45 for residential and \$165 for commercial applications. The purpose of the fee increase is to offset the cost of record management for all job applications of New Building and Alterations 1, 2, and 3. Record management includes scanning, imaging, off-site storage and microfilming. The proposed increase is \$45 for 1, 2, and 3 family homes and \$165 for all other properties such as multiple dwelling and commercial. The Department is projecting filings of 54,800 applications annually, which will generate \$5.7 million in Fiscal 2011 and the outyears.
- Low and High Pressure Boiler Application Fees. The Department will establish new fees for low and high pressure boiler applications. The provisions in the low pressure and high pressure boiler rules require new filing requirements for the following: affirmation of correction of unsafe boiler (\$30); request for waiver of violations (\$30); certification of removal (\$45); and extensions (\$15). The new proposed fees will generate \$500,000 in Fiscal 2011 and in the outyears.
- Elevator Application Filing Fees. The Department will generate additional revenue by implementing various elevator application fees. The provisions in the elevator rules require new filing requirements for the following: affirmation of correction of unsafe elevator (\$45); request for waiver of violations (\$40); and three year and five year reports for hydraulic type elevators (\$45). The new proposed fees will generate \$1.7 million in Fiscal 2011 and in the outyears.
- **Façade Application Filling Fees.** The Department will institute new façade application fees. The provisions in the facade rule require fees for existing filing requirements (reports) for the following: façade walls reports (\$275); amendments (\$100); and extensions (\$140). The new proposed fees will generate \$800,000 in Fiscal 2011 and in the outyears.
- **Hazardous Re-inspections.** State law allows DOB to re-inspect buildings that pose a threat of imminent danger to public safety or property every 60 days after the issuance of a violation. The Department estimates it will realize additional fine revenue of \$2 million in Fiscal 2011 and in the outyears by conducting these State mandated Class 1 hazardous re-inspections.
- **Proposed Staffing Reductions.** The Department's Executive Plan includes a savings of \$1.43 million in Fiscal 2011 and \$1.66 million in Fiscal 2012 and the out-years for the reduction of 20 staff from Borough Support Units and other Central Units that have experienced decreased workloads. The exact titles/positions have not been identified yet.

### **Other Adjustments**

The Executive Plan contains \$6.41 million in Fiscal 2011 and \$535,000 in the outyears in City-funded Other Adjustments:

- **Private Elevator Inspection Contracts.** The Executive Plan includes an additional \$3.1 million in Fiscal 2011 for the continuation of elevator inspection contracts.
- **Roll OTPS Funds.** The Department's budget will rollover OTPS funds totaling \$2.42 million from Fiscal 2010 to Fiscal 2011. Approximately \$1.9 million of the roll is for contracts with registration delays, including engineering and investigation contracts following up on the crane collapse. The remaining \$500,000 is for OTPS costs associated with new programs that experienced delays in start up, including the new concrete testing unit.
- **Credit for fringe benefits savings associated with PS reductions.** The Department's budget increased by \$125,000 in Fiscal 2011 and \$350,000 in the outyears as credit for fringe benefits savings associated with Personal Service reductions.
- **Collective Bargaining.** The Department's budget increased by \$45,000 in Fiscal 2011 and in the outyears to cover the costs associated with collective bargaining settlements.
- **Heat, Light and Power.** The Department will generate savings of \$121,000 in Fiscal 2011 and in the outyears for heat, light and power.
- **Lease Adjustment.** The Department's budget will increase by \$18,900 in Fiscal 2011 and in the outyears as a result of lease adjustment.
